Holz families,

I just want to thank you for making this year successful. Our families rallied around our school to create wonderful school events such as Grandparents Lunch, Family Night Out, Carnival and Teacher Appreciation Week. Over the summer, be sure to keep your children reading and even review math concepts.

We typically see students drop a half a grade level over the summer months. This is called the "Summer Slide". We then have to spend the first semester just reviewing last year's skills. There are summer camps at the library and at the Clay Center. You will also have access to ST Math. Your child does not even need a code. Teachers will assign all objectives in the students' current grade level for homework. This is a great tool to keep students engaged and learning. More information will come home in the child's final Friday Folder.
